ABOUT THE COLLEGE

Government Degree College, Darlaghat, District Solan, is situated on the Shimla-Bilaspur-Kangra Highway, just over a kilometer ahead of the Darlaghat Bus Stop towards Bilaspur. It overlooks the charming and picturesque Darla Hills. The college was established on May 23, 2017, with the aim of making quality higher education accessible to Darlaghat and its surrounding regions. It is currently operating in a privately hired complex. The Government Degree College, Darlaghat has received administrative approval for a whopping ₹14.6 crore for construction of college building. The college has also acquired 43.1 bigha of land for same. Construction work is progressing steadily, with the foundation work nearing completion. As per information received from the government, the department has set a deadline of 18 months to complete the project. From academic session 2026 -2027, students can expect to enjoy the benefits of state-of-the-art facilities.

Darlaghat is a sub-tehsil and a panchayat in Solan District. Interestingly, it derives its name from "Dadu," a wild sour pomegranate that grows prolifically in the area. The region is primarily known for Dadu fruit and its limestone resources. The Ambuja Cement Factory, established in 1995, serves as the economic lifeline of the region, fostering the development of a vibrant market that connects the surrounding areas. As a result, the region hosts a substantial migrant population.

What gives Darlaghat its distinct identity is its "Rurban" nature—a blend of rural and urban characteristics. Just beyond the highway, the factory, and the bustling market, one can find lush maize fields, cows lazily grazing on hay, and the familiar sight of hardworking Indian farmers. 4. GENERAL ADMISSION RULES

4.1 Eligibility for Admission

A candidate will be eligible for admission to the First Year of the three-year degree course if he/she fulfils the eligibility conditions as prescribed by HPU Shimla, which are subject to amendment from time to time. In general:

- A candidate should have passed 10+2 examination conducted by HP Board of School Education or an examination recognized as equivalent thereto by HP University, Shimla.
- ii. For admission to First Year, an applicant must not be more than 23 years of age (25 years for girl students) as on 01-07-2025. The upper age limit for SC/ST candidates is 26 years. However, the Vice Chancellor, HPU Shimla in exceptional circumstances, to be recorded in writing, may allow a relaxation in age up to a period of six months.
- iii. The students having compartment in 10+2 class are not eligible for admission.

4.2 Admission Procedure

- Admission will be granted strictly on merit basis and fulfilment of eligibility conditions.
- 2. To apply for admission, candidates should visit the admission portal on the college website at www.gdcdarlaghat.edu.in. Follow the instructions carefully and fill the online application form, upload the required documents, and submit through the portal only. Applications and documents submitted uploaded only on the admission portal of the College will be accepted.
 No application/ document sent on college or any other mail is acceptable.
- 3. In the course of the admission process, students can approach members of the admission committee. In addition, to facilitate students, the Galaxy Print Studio, a cybercafe is functional within the Gollege campus and adequate instructions have been given to the studio to aid students throughout the admission process.
- Students require an E-mail ID to create an account on our admission portal for online admissions. For second- and third-year students existing E-mail ID, used for admission, is required for roll on admission.
- 5. A student applying for admission in B.A. 1st year is advised to give two subjects/courses of her/his choice, choosing at least one course from any two of the three groups. A candidate has to choose two subjects from the list (page no. 12), as DSC I and DSC II. Both DSC I and DSCII cannot be opted from the same group.
- 6. The application form is to be filled up by the applicant after reading all the instructions, rules and eligibility conditions. The submission of application form for admission shall imply that the applicant is familiar with admission rules and code of conduct in the college and has agreed to abide by the same.

- Subject wise ment list will be displayed on the college website and the college notice board
 on the scheduled dates.
- The admission forms of the candidates appearing in the ment list will be scrutinized online by the concerned Admission Committee.
- The admission form recommended by the Admission Committee and approved by the Principal entitles a student to deposit the prescribed fee within the stipulated period.
- Roster for reservation of seats in various categories shall be as per rules of H.P. University, Shimla.
- Incomplete admission forms and those without copies of upleaded documents will not be entertained.
- 12. Every student seeking admission to any class will be required to pay a sum of ₹500/- per annum towards PTA fund (non-refundable). However, in case of more than one child of the same parents, PTA fund will be charged from one of the student's subject to production of valid documents.
- 13. No admission, whatsoever, shall be made after the due date.
- 14. All admissions will be as per admission schedule notified by H.P. University from time to time.
- 15. All admissions will be provisional subject to the approval of Vice Chancellor, HPU Shimla
 16. All the fee and funds are to be deposited within the stipulated time period.

Note: If a candidate does not deposit fees within the stipulated time period, his/her admission will be deemed cancelled.

Important: The students, who are required to produce affidavits for admission, must consult the admission committee about the contents/statement to be given in the affidavit so that any inconvenience at later stage may be avoided. Submission of false affidavit is a legal offence.

4.3 Counseling

- Online admission will not guarantee admission to the College, unless the candidate produces all original certificates and documents (uploaded while applying for admission) at the time of physical verification during the counseling.
- Counseling in physical mode will be organized for first year students on 24 June 2025 (tentative).
- Students must be accompanied by a parent/guardian to the counseling.

4.4 Migration

Migration from any other College to Govt. Degree College, Darlaghat or vice-versa is governed by H.P. University rules. Fees and funds will be charged from student as per Govt and University rules. PTA Fee is not refundable in any case.

5. DOCUMENTS REQUIRED FOR ADMISSION

- 1. Matriculation certificate for Date of Birth
- 2 10+2 markssheet.
- H.P. Bonafide certificate for girl students (for exemption in tuition fee).
- Minimum 40% disability certificate and category certificate in case of students seeking admission against these seats.
- Original character certificate from Head of the Institution last attended. In case of
 private candidates, the character certificate must have been issued by a Gazetted officer/
 Panchayat Pradhan/ Ward Counsellor but not older than 6 months from the day of
 submission of admission form.
- For seat against the single girl child category 'an Affidavit proclaiming the same from the parents is to be submitted with the admission form.
- A student seeking admission from Board University other than H.P. will have to upload
 the copy of migration certificate and the original certificate has to be submitted at the
 time of counseling.
- A candidate having a gap of one or more years in his/her studies will have to submit an
 affidavit issued by court only, explaining the reasons thereof.
- Certificate of SC/ ST from Magistrate Class-1 (Authorised Signatory) should be provided by those seeking relaxation in age/ marks
- 10. Any gap (latest) in the academic career of the applicant must be supported by a documentary evidence / affidavit as proof of his/her activities during the period of gap.

NOTE

- Every student must have his her own e-mail ID.
- Parents must ensure the entry of their Mobile No. in the admission form in order to make it convenient to send them important messages.

IMPORTANT: STUDENTS MUST REMEMBER THEIR USER ID, E-MAIL ID, PASSWORD AND REGISTERED MOBILE NUMBERS FOR FUTURE REFERENCE/USE.

6. NUMBER OF SEATS AVAILABLE AND RESERVATION OF SEATS

- For admission to first year in each subject, as First Elective, total number of available seats will be 120.
- However, the number of seats in Elective II for B.A. I students will also be restricted depending upon the availability of faculty and infrastructure.

Important: All admissions will be made as per the reservation criteria of the state government and university roaster in this regard except when under application received.

8. REFUSAL OF ADMISSION

- A candidate expelled by any college university or found involved in any act of indiscipline in the preceding year(s) will not be admitted to the college.
- The students having compartment in 10+2 class are not eligible for admission.
- Any candidate who has not appeared passed in English as a subject at 10+2 level shall not be eligible for admission to B.A. I year.

- 4. If a student gets admission by furnishing incorrect information or by concealing facts, his her admission will be cancelled on detection of such fault by the college/university.
- The Principal reserves the right to reject or cancel the admission of any student, or to expelsuspend him her, without assigning any reason(s) or explanations, if situation so warrants.
- Failed students of other colleges will not be admitted.

9. COURSE DESIGN/ STRUCTURE OF B.A./B. Com

The subject wise syllabus and design of BA and B.Com is available on given link https://hpuniv.ac.in/syllabus.php

9.1 Award of Degree

- 1. An undergraduate degree in Humanities/ Social Sciences/ Commerce may be awarded if a student completes 4 core papers each in two disciplines of choice, 2 core papers each in English and Hindi/MIL, respectively, 2 Ability Enhancement Compulsory Courses (AECC), minimum 4 Skill Enhancement Courses (SEC), 2 papers each from a list of Discipline Specific Elective Papers based on the two disciplines of choice selected above, respectively, and 2 papers from the list of Generic Elective papers.
- 2. A regular candidate shall have to undergo the prescribed courses of study in the college for a period not less than three academic years (and not more than five academic years), and shall have to pass the examinations prescribed and fulfil such conditions as have been prescribed thereof.
- 3. For the degree (B.A./ B. Sc./ B. Com.), the student will have to cumulate a minimum of 132 successful credit hours of coursework over a minimum of three and a maximum of five years from the date of admission.

9.2 Accumulation of Credits & Evaluation System

1. Accumulation of Credits

A student will have to accumulate 132 credits for a bachelor's degree over a minimum of three and maximum of five years from the date of admission. For the successful completion of a course, a student is required to obtain minimum 35% marks separately in CCA and ESE/Annual and at least 40% (45% for Semester System) marks in aggregate of ESE/Annual & CCA.

2. Evaluation System

Evaluation System has the following components:

- a. Continuous Comprehensive Assessment (CCA): It will account for 30% of the final grade which is further distributed as follows:
 - Classroom Attendance: A student has to attend a minimum of 75 % lectures/tutorials and practical failing which he she will not be allowed to appear in End Terms Examinations. The incentive for classroom attendance is:

75% but <80%	1 Marks
80% but <85%	2 Marks
85% but <90%	3 Marks
90% but <95%	4 Marks
More than 95%	5 Marks

- Mid-Term Test (MTT): There will be one mid-term test in each year and one class test of 10 and 5 marks respectively.
- Seminar/ Assignment/Term Paper: The remaining 10 marks will be awarded on the basis of seminar/ assignment/term papers.

b. Term End Examinations: The 70% of the final grade for in a course will be on the basis of Annual Examinations of 3 hours duration covering the whole syllabus.

NOTE: Only those students will be eligible to appear in the End Term Examinations who have passed in CCA.

Important excerpt from proceedings of Deans/Chairpersons and Directors of various teaching departments/bodies of HP University, Shimla dated 13th June 2018 regarding passing examinations and award of degree (for annual system)

"A candidate failing in either one or two subjects papers will be given compartment in that subject papers and will be eligible for promotion to the next class. He she will appear in the subject paper in which he she got the compartment. He she will have two chances (one at the supplementary stage and one at the annual stage), available to him to clear his her compartment in subjects papers. He she will not be awarded the degree until he she clears all his her courses within five years from the date of his her admission to a particular course. A candidate failing in three or more subjects papers will be treated as fail in that year and has to repeat the entire year."

9.3 Change of subject/faculty

Change of subject faculty is allowed only once and that too in the first year within 15 days of the commencement of teaching provided:

He she fulfils eligibility criteria

Seats are available in the concerned subject

Hence, a student is expected to be very careful while exercising the option for the first time in order to save himself from inconvenience later.

Note: Change of subject combination without the approval of Head of the Institution on prescribed Performs will not be entertained and such change in final examinations will not be considered. Students will be personally responsible for such acts

10. GENERAL CONDUCT AND DISCIPLINE RULES

All the students must note that ragging inside/ outside the college campus or on roads leading to college is a cognizable offence. In addition, any of the following activities will be considered a breach of discipline:

- a) Graffiti, i.e. any sort of writing on the walls blackboards rooms, etc.
- b) Damaging the college property in any manner.
- c) Loitering about the corridors and causing disturbance to the classes.
- d) Possession or use of drugs and indulgence in smoking or drinking in and around the campus.
- e) Bringing outsiders to the college.
- f) Sticking any kind of bills/notice on the notice board without the prior permission of the Principal
- g) Creating any kind of violence or nuisance in the campus.
- h) Coming to the college without I-Card.
- Use of the mobile phones in and around the classroom(s) and Examination-Hall(s).

[Use of the mobile phones by the students in and around the classroom(s) and Examination-Hall(s) is strictly prohibited.]

Caution

- Strict action will be taken against the student found guilty of breaching conduct or discipline rules in the college campus.
- Defaulters including students whose names have been struck off the roll(s) will not be allowed to enter the college premises until exonerated or readmitted appropriately.

11. ATTENDANCE

- A minimum of 75% lecture attendance is mandatory for a student to be eligible to appear in the annual/end-semester examinations of Himachal Pradesh University (HPU).
- 2. The name of any student who is irregular in attendance or remains absent continuously for ten (10) days from the college/ any elective subject shall be struck off the college rolls. In the event that a student's name is struck off on two occasions, he or she shall not be eligible for readmission. It may be noted that admission/readmission to college is not the right of any student/candidate.
- A student shall be liable to pay all dues and fines as long as his or her name remains on the college rolls, regardless of attendance or academic performance.

12. LEAVE RULES FOR STUDENTS

- It is compulsory for all students to get their leave sanctioned by the Dean of the Faculty before proceeding on any kind of leave.
- For leave on medical grounds extending more than a week, the student will be required to submit a medical certificate.
- Leave up to one week will be sanctioned by the Dean of the Faculty. For leave extending beyond one week, the student shall have to apply to the Principal.
- A student will not be allowed to avail more than 10 days of leave during the entire academic session, except under exceptional circumstances.
- If a student is regularly skipping classes or does not submit assignments, his/her name will be struck off from the rolls of the College.
- Even if a student is on leave, he she will have to deposit the fee as per the scheduled dates decided by the College.
- 7. Students can seek re-admission twice during the session. The first re-admission will be allowed within three days after the name is struck off, after paying a fine of ₹100/-. A fine of ₹200/- will be charged for the second re-admission within 10 days after the name is struck off from the rolls.

13. LIBRARY RULES

The following shall be entitled to use the college library and borrow books for home reading:

- The library will be open from 10 A.M. to 5 P.M. on all working days.
- Students shall be permitted to keep books for a period of two weeks.

- A fine of Rs. 1/- per day per book will be charged from the student for keeping books beyond the period of two weeks.
- 4. Faculty members can borrow four books at a time.
- Library books will be issued to a student only upon production of a duly signed Identitycum-Library Card.
- A student will be responsible for all the books issued to him or her on the card, even if the card is lost.
- Marking, underlining, or writing on library books is strictly forbidden.
- The loss of the Identity-cum-Library Card should be immediately reported to the librarian. A duplicate card shall be issued on payment of the prescribed fee.
- Any borrower, who loses, defaces, or in any way damages a library book shall be liable to pay the current price of the book.
- 10. A 'No Dues Certificate' is to be obtained from the librarian by each student while withdrawing from the college.
- 11. Perfect order and silence shall be maintained in the library at all times.

ID CARD

Every student will be issued an Identity Card. Since the I-Card is the only medium to identify/differentiate a bonafide college student from an outsider, every student must always carry it with him her. Otherwise, he she will be considered an outsider, and action will be taken accordingly.

- If the I-Card is lost, a duplicate card will be issued only after an FIR is registered with the nearest police station and the original copy thereof is appended with such a request.
- The actual amount will be charged for the issuance of a duplicate Identity Card.

Note: A duplicate Identity Card will be issued only after proof of FIR registered with the nearest police station is attached with the application.

25.2 Research and Consultancy

The College accepted a consultancy request, dated 20 September 2024, from Dr. Asaf Sharabi, Ph.D., Senior Lecturer at Peres Academic Center, Israel, for a comparative ethnographic research project on Gods and Goddesses in the Western Himalaya. The college faculty and students were involved in the project. They contributed by ethnographic research logistics and fieldwork, providing cultural insights into regional deity worship, and engaging in academic discussions to refine interpretations.

This collaboration strengthened international academic ties, enriched faculty and student engagement in ethnographic research, and provided valuable learning experiences for students. The consultancy successfully facilitated knowledge exchange and reinforced the institution's dedication to interdisciplinary research.

25.3 National Seminar on International Women's Day

On 8 March 2025, a one-day national seminar titled Women: History & Beyond" was held in hybrid mode to mark International Women's Day. Keynote speaker Prof. Dr. Anu Mehra from Delhi University, along with other prominent national and international scholars, delivered lectures on topics like women's rights, Vedic traditions, and women's roles in literature and the gig economy. Research papers were presented, and the event concluded with active participation from all students.

25.4 Library Expansion & Digital Initiative

The library has been established with the arrival of the new librarian in January 2024. Adequate arrangements have been made to ensure conducive atmosphere in the library.
